The following criteria is required

1. **Application** - Complete all four (4) pages. (On the third page your signature must be notarized).
2. **Photo Id**- (drivers license) will suffice
3. **State of Maryland Master Electricians License** - A copy current State of Maryland License must accompany the application.
4. **Fee** - The fee is \$150.00 *please make the check payable to Talbot County*, not to the Board of Electrical Examiners. (This office accepts checks only.)
5. **Insurance Certificate** - **The certificate of insurance must have the electrician name on it** as well as the company name and address *we do not accept certificates with only the company name*; Certificate Holder is The Talbot County Board of Electrical Examiners at 215 Bay Street, Suite 3, Easton, Maryland 21601.
