Plumbing Application and Renewal Requirements

Please provide the following information:

1. A completed Plumbing License application.
2. Using the attached form, list journeyman applications, if issued to master applicants, by name and state license number and **journeyman plumbers will not receive a registration card** from the County.
3. A copy of each current Maryland State Plumbing License for the master and journeyman applicants submitted.
4. A copy of the Certificate of Insurance for master plumbers or written proof of valid exemption, per Section 462C (b), Article 56 of the *Annotated Code of Maryland*.

Note: Minimum liability insurance in effect shall be \$300,000 bodily injury and \$100,000 property damage. The certificate of insurance must state the plumber's personal name, company name and address. It must also indicate the certificate holder as Talbot County Planning and Permits Department, 215 Bay Street, Suite 2, Easton, MD 21601.

5. The fee for Master License is \$75.00 and Journeyman is \$10.00 please make checks payable to Talbot County. This office does not accept cash.
6. Copy of photo identification for Master Plumber (driver's license, etc.).

Thank you in advance for your response. Submission of all necessary information and payments are required for a Talbot County plumbing license to be issued. This license authorizes its holder to perform professional plumbing work in Talbot County. Please carefully review the application to ensure its completeness.
