WHEREAS, Salvia is known to be a hallucinogenic psychoactive substance that can cause a loss of physical coordination, visual alterations or visions, multiple realities, a sense of total confusion or madness, a sense of flying, floating twisting or turning, a loss of sense of awareness as an individual, and other hallucinations; and

WHEREAS, the Talbot County Council believes that it is in the best interest of the health, safety and general welfare of its citizens and visitors to prohibit the possession and distribution of salvia, and its related paraphernalia.

SECTION ONE: BE IT ENACTED BY THE COUNTY COUNCIL OF TALBOT COUNTY, MARYLAND, that the Talbot County Code shall be and is hereby amended by adding Chapter 119 entitled "Public Health," Article I, entitled "Salvia" as set forth herein.

- defined and set forth in § 5-101 Criminal Law Article, Md. Ann. Code, pursuant to the
- factors set forth in § 5-619 Criminal Law Article, Md. Ann. Code.

SECTION TWO: BE IT FURTHER ENACTED, that this ordinance shall take effect sixty (60) days from the date of its passage.

SECTION THREE: AND BE IT FURTHER ENACTED, That if any provision of this Ordinance or the application thereof to any person or circumstance is held invalid for any reason in a court of competent jurisdiction, the invalidity does not affect other provisions or any other application of this Ordinance that can be given effect without the invalid provision or application, and for this purpose the provisions of this Ordinance are declared severable.
