A BILL TO AMEND § 11-7 A. AND § 11-7 B., TALBOT COUNTY CODE “ALCOHOLIC BEVERAGES,” TO REVISE THE HOURS A HOLDER OF A SPECIAL CLASS H AND SPECIAL CLASS J LICENSE CAN KEEP FOR SALE AND SELL ALCOHOLIC BEVERAGES

A BILL TO AMEND § 11-7 A. AND § 11-7 B., TALBOT COUNTY CODE “ALCOHOLIC BEVERAGES”, TO REVISE THE HOURS A HOLDER OF A SPECIAL CLASS H AND SPECIAL CLASS J LICENSE CAN KEEP FOR SALE AND SELL ALCOHOLIC BEVERAGES

SECTION ONE: BE IT ENACTED BY THE COUNTY COUNCIL OF TALBOT COUNTY, MARYLAND, that § 11-7 A. and § 11-7 B., Talbot County Code “Alcoholic Beverages” shall be and are hereby amended as follows:

* * *

§ 11-7 Special and temporary licenses

A. Special beer and light wine license, Class H (on-sale), seven days

...

(2) Hours. The hours during which the privileges conferred by a Class H license may be exercised shall be from ~~12:00 noon~~ 10:30 a.m. to 12:00 midnight each day; provided, however, that the sale and consumption of beer and light wine shall be restricted to a period of time beginning two hours before the scheduled entertainment and concluding one hour after said entertainment.

B. Special beer, wine and liquor license, Class J (on-sale), seven days

...

(2) Hours. The hours during which the privileges conferred by a Class J license may be exercised shall be from ~~12:00 noon~~ 10:30 a.m. to 12:00 midnight each day; provided, however, that the sale and consumption of beer, wine and liquor shall be restricted to a period of time

beginning two hours before the scheduled entertainment and concluding one hour after said entertainment.

SECTION TWO: BE IT FURTHER ENACTED, that the title and summary of this Bill shall be published once on the first publication date after enactment of the Bill in accordance with County Charter § 213 (c). The title is not a substantive part of this Bill. If the Bill is amended, the title may be administratively revised if required to conform the title to the content of the Bill as finally enacted.

SECTION THREE: AND BE IT FURTHER ENACTED, that if any provision of this Ordinance or the application thereof to any person or circumstance is held invalid for any reason in a court of competent jurisdiction, the invalidity does not affect other provisions or any other application of this Ordinance which can be given effect without the invalid provision or application, and for this purpose the provisions of this Ordinance are declared severable.

SECTION FOUR: AND BE IT FURTHER ENACTED, that the publishers of the Talbot County Code or the Talbot County Office of Law, in consultation with and subject to the approval of the County Manager, may make non-substantive corrections to codification, style, capitalization, punctuation, grammar, spelling, and any internal or external reference or citation included in this Bill, as finally adopted, that are incorrect or obsolete, with no further action required by the County Council. All such corrections shall be adequately referenced and described in an editor's note following the section affected.

SECTION FIVE: AND BE IT FURTHER ENACTED, that this Bill shall take effect sixty (60) days from the date of its passage.

PUBLIC HEARING

Having been posted and notice of time, date, and place of hearing, and Title of Bill No. 1300 having been published, a public hearing was held on Tuesday, April 14, 2015 in the Bradley Meeting Room, South Wing, Talbot County Courthouse, 11 N. Washington St., Easton, Maryland.
