A BILL TO AMEND BILL NO. 1118, INCREASING THE APPROPRIATION FOR CONSTRUCTION OF A BOAT RAMP AT WYE LANDING

BE IT ENACTED BY the County Council of Talbot County, Maryland, as follows:

SECTION 1: Construction of an additional boat ramp at Wye Landing is hereby authorized as a capital project. The scope of work includes, but is not limited to, the planning, design, and construction of a wider boat ramp, boarding piers, finger piers, and mooring piles at Wye Landing. The purpose of the new ramp and boarding piers is to upgrade a deteriorating structure and to provide better service to the boating public during peak use periods. The purpose of the finger piers and mooring piles is to provide four (4) boat slips.

SECTION 2: The Talbot County Council is hereby authorized to expend up to \$375,000 for construction of a boat ramp at Wye Landing. This represents an increase of \$175,000 over prior authorization. The project will be funded by federal and State grants of approximately \$275,000 and County funds of approximately \$100,000. The increase will be funded by federal and State grants of approximately \$175,000.

SECTION 3: This Ordinance will take effect sixty (60) calendar days from the date of enactment.

The purpose of the new ramp is to upgrade a deteriorating structure and to provide better service to the boating public during peak use periods. The purpose of the new pier and mooring slips is to upgrade a deteriorating structure and to provide twelve (12) boat slips.

SECTION 2: The Talbot County Council is hereby authorized to expend up to \$300,000 for improvements to the Oak Creek Landing boat ramp. This represents an increase of \$200,000 over prior authorization. The project will be funded by federal and State grants of approximately \$150,000 and funds from the Capital Projects Fund of approximately \$150,000. The increase will be funded by federal and State grants of approximately \$50,000 and approximately \$150,000 of funds from the Capital Projects Fund.

SECTION 3: This Ordinance will take effect sixty (60) calendar days from the date of enactment.
