A RESOLUTION TO CHANGE THE TRAFFIC CONTROL REQUIREMENTS IN THE CONSTRUCTION SPECIFICATIONS FOR COUNTY ROADWAYS

SECTION ONE: BE IT RESOLVED BY THE COUNTY COUNCIL OF TALBOT COUNTY, MARYLAND, that the following amendments to Talbot County’s *Specifications for Construction Within Talbot County Roadways* shall be and are hereby adopted:

12. On-site Traffic ~~Manager~~ Control required.

1 The Permittee shall have a MD SHA-certified Traffic ~~Manager~~ Flagger on-site who shall
2 be in charge of the site within the traveled Roadway. ~~The Traffic Manager shall be~~
3 ~~authorized to call in repair crews, if necessary, at any time.~~ The Traffic ~~Manager’s~~
4 Flagger’s name and emergency contact number(s) shall be provided to the Superintendent
5 and this information shall be promptly updated and communicated to the Superintendent
6 as necessary until final completion and project approval. The Superintendent may
7 increase traffic control requirements whenever necessary to promote public safety.
