A RESOLUTION TO ADOPT THE SOLID WASTE MANAGEMENT PLAN DATED JULY 2009, TALBOT COUNTY, MARYLAND; PURSUANT TO THE POWER AND AUTHORITY CONTAINED IN THE ENVIRONMENTAL ARTICLE, TITLE 9, SUBTITLE 5 OF THE ANNOTATED CODE OF MARYLAND

WHEREAS, the County Council of Talbot County, State of Maryland, by Resolution 27 adopted the last Solid Waste Management Plan in 1978; and

WHEREAS, said Plan is necessary for the protection of the health, safety, and welfare of the public; and

WHEREAS, in order to protect the health, safety, and welfare of the public, Talbot County is required to adopt a plan to assure the proper and legal handling and disposal of solid waste generated in the County; and

WHEREAS, the Solid Waste Management Plan has been prepared and certified to be in compliance with the policies and regulations of governing bodies and agencies having jurisdiction in Talbot County;

NOW, THEREFORE, be it resolved by the County Council of Talbot County, Maryland as follows;

Section 1: The County Council is acting pursuant to Title 9, Subtitle 5, of the Environment Article of the Annotated Code of Maryland.

Section 2: Upon conclusion of the public hearing(s), closing of the public record, receipt and consideration of certifications and recommendations from the Planning Commission and Public Works Advisory Board, the County Council will discuss the merits of the Resolution, and decide to approve or disapprove the proposed Resolution.

Section 3: The Solid Waste Management Plan, attached hereto as Exhibit A, is hereby adopted.

Be it further resolved that this Resolution shall take effect immediately upon its date of passage.
