A BILL TO AUTHORIZE AN INTERPROJECT TRANSFER OF ONE MILLION TWO HUNDRED THOUSAND DOLLARS (\$1,200,000.00) FROM THE CAPITAL PROJECT FOR "COUNTY OFFICE/PLANNING/CONSTRUCTION/RENOVATION" TO THE CAPITAL PROJECT FOR "HOSPITAL RETENTION -- LAND ACQUISITION"

SECTION ONE: BE IT ENACTED BY THE COUNTY COUNCIL OF TALBOT COUNTY, MARYLAND, that the following interproject transfer between capital projects shall be and is hereby adopted as set forth herein.

The Annual Budget and Appropriation Ordinance for FY 2008 included an appropriation of Eight Hundred Thousand Dollars (\$800,000.00) for a capital project entitled, "Hospital Retention-Land Acquisition".

The Annual Budget and Appropriation Ordinance for FY 2008 also included an appropriation of Three Million Dollars (\$3,000,000.00) for a capital project entitled, "County Office/Planning/Construction/Renovation".

Talbot County desires to acquire an additional parcel of land adjacent to the parcel the County has previously indicated it would offer to Shore Health Systems, Inc. in connection with retention of its existing hospital facilities in Easton or its immediate environs.

Talbot County has solicited an offer of sale for that purpose and desires to enter into a Contract of Sale for the purchase of approximately 160 acres of land for a total purchase price of Two Million Dollars (\$2,000,000.00).

Talbot County hereby transfers One Million Two Hundred Thousand Dollars (\$1,200,000.00) from the capital project entitled "County Office/Planning/Construction/Renovation" to the capital project entitled "Hospital Retention-Land Acquisition," making the total appropriation for the latter capital project Two Million Dollars (\$2,000,000.00).

SECTION TWO: BE IT FURTHER ENACTED, that this Ordinance shall take effect sixty (60) days from the date of its passage.

SECTION THREE: AND BE IT FURTHER ENACTED, That if any provision of this Ordinance or the application thereof to any person or circumstance is held invalid for any reason in a court of competent jurisdiction, the invalidity does not affect other provisions or any other application of this Ordinance which can be given effect without the invalid provision or application, and for this purpose the provisions of this Ordinance are declared severable.
