**A BILL TO AMEND BILL NO. 1170, INCREASING THE APPROPRIATION  
FOR A PUBLIC LANDING MAINTENANCE PROGRAM**

BE IT ENACTED BY the County Council of Talbot County, Maryland, as follows:

SECTION 1: A Public Landing maintenance program is hereby authorized as a capital project. The scope of work includes, but is not limited to, maintenance repairs to existing public landings.

SECTION 2: The Talbot County Council is hereby authorized to expend up to \$437,000 for this project. This represents an increase of \$189,000 from prior authorization. The project will be funded by federal and State grants.

SECTION 3: This Ordinance will take effect sixty (60) calendar days from the date of enactment.

**A BILL TO AUTHORIZE AN INTER-PROJECT TRANSFER OF APPROPRIATIONS; TO TRANSFER \$100,000 FROM THE APPROPRIATION APPROVED BY BILL NO. 1129 FOR THE DESIGN, ENGINEERING, AND CONSTRUCTION OF DUTCHMANS LANE ROAD IMPROVEMENTS TO THE APPROPRIATION APPROVED BY BILL NO. 1189 FOR DESIGN, ENGINEERING, AND CONSTRUCTION OF DUTCHMANS LANE CULVERT AND BRIDGE**

BE IT ENACTED BY the County Council of Talbot County, Maryland, as follows:

SECTION 1: The appropriation authorized by Bill 1129 for the engineering, design, and construction of road improvements to Dutchmans Lane shall be and is hereby reduced by \$100,000. The scope of work in this capital project includes, without limitation, acquisition of necessary easements, rights of way, or fee simple interests, road widening, repaving, and pavement upgrades from the Windmill Branch stream crossing on Dutchmans Lane to the road frontage adjacent to Easton Club East. The total appropriation for this capital project is hereby amended to not more than \$2,300,000, a decrease of \$100,000 less than the prior appropriation. The project will be funded by federal and State grants of approximately \$1,000,000, County funds of approximately \$444,000, and Development Impact Fees of approximately \$856,000. The amount of the decrease in the appropriation for this capital project will be transferred to the capital project for construction of a culvert and bridge at the Windmill Branch stream crossing on Dutchmans Lane.

SECTION 2: The appropriation for construction of a culvert and bridge at the Windmill Branch stream crossing on Dutchmans Lane is hereby increased by \$100,000. The scope of work in this capital project includes, without limitation, the design and construction of a bottomless culvert for the Windmill Branch stream crossing on Dutchmans Lane to enhance pedestrian and traffic safety. The total appropriation for this capital project is hereby amended to not more than \$1,919,000, an increase of \$100,000. The project has been funded by approximately \$885,000 in State and Federal grants, and Development Impact Fees of approximately \$934,000. The amount of the increase in the appropriation for this capital project will be transferred from the capital project for construction of a culvert and bridge at the Windmill Branch stream crossing on Dutchmans Lane.

SECTION 3: This Ordinance will take effect sixty (60) calendar days from the date of enactment.

**A BILL TO AMEND BILL NO. 1193, TO INCREASE THE APPROPRIATION FOR THE PLANNING, DESIGN, CONSTRUCTION AND/OR RENOVATION AND EQUIPPING OF THE EASTON LIBRARY AND UPGRADING OR REPLACING TELEPHONE SYSTEMS AT EASTON, ST. MICHAELS AND TILGHMAN LIBRARIES BY \$150,000 OF GRANT FUNDING**

BE IT ENACTED BY the County Council of Talbot County, Maryland, as follows:

SECTION 1: The renovation of the Easton Library and the upgrade of the telephone systems at Easton, St. Michaels and Tilghman Libraries has been previously authorized as a capital project. The capital project included, without limitation, the planning, design, renovation, and equipping of existing facilities, and/or construction of new facilities for the Easton Library, and upgrading or replacement of telephone systems at Easton, St. Michaels and Tilghman Libraries.

SECTION 2: The County is hereby authorized to increase the total appropriations for this capital project up to and including the amount of \$7,019,970. This represents an increase of \$150,000 over prior appropriations. The increase will be funded by federal and State grants of approximately \$150,000. Previous appropriations included funding from Development Impact Fees of approximately \$369,970, and County funds of approximately \$6,500,000.

SECTION 3: This Ordinance will take effect sixty (60) calendar days from the date of enactment.
