A BILL TO AUTHORIZE A CAPITAL PROJECT FOR IMPROVEMENTS TO AIRPORT ROAD

BE IT ENACTED BY the County Council of Talbot County, Maryland, as follows:

SECTION 1: The improvement of Airport Road is hereby authorized as a capital project. The scope of work includes, but is not limited to, surveying and right of way acquisition for the future design, engineering, property acquisition, drainage improvements, and construction and widening of Airport Road between Maryland Rt. 50 to Goldsborough Neck Road in order to improve traffic safety. Approval of this capital project includes authorization to expend funds, not to exceed the total amount of the appropriation, for all incidental and customary costs and charges associated with and reasonably necessary for design, engineering, construction and completion of the project.

SECTION 2: The Talbot County Council is hereby authorized to expend up to \$1,700,000 for the Airport Road project. The project will be funded by Development Impact Fees of approximately \$700,000 and funds from the Capital Projects Fund of approximately \$250,000 and Cost Sharing funds of \$750,000.

SECTION 3: This Ordinance will take effect sixty (60) calendar days from the date of enactment.

A BILL TO AMEND BILL NO. 1419, THE APPROPRIATION FOR A CAPITAL PROJECT FOR THE INSTALLATION OF A BELT FILTER PRESS TO UPGRADE THE REGION II (ST. MICHAELS) WASTEWATER TREATMENT PLANT

WHEREAS Bill No. 1419 authorized the installation of a belt filter press to upgrade the Region II (St. Michaels) Wastewater Treatment Plant;

NOW, THEREFORE, BE IT ENACTED BY the County Council of Talbot County, Maryland, as follows:

SECTION 1: The installation of a belt filter press to upgrade the Region II (St. Michaels) Wastewater Treatment Plant to dewater sludge is hereby authorized as a capital project. The scope of work includes, but is not limited to, the planning, design, preparation of construction documents and the purchase of, and installation of, a belt filter press at the Region II (St. Michaels) Wastewater Treatment Plant, and the cost of issuance of any bonds needed to finance the project.

SECTION 2: The Talbot County Council is hereby authorized to expend up to \$600,000 for the project. This project is to be funded with long-term borrowing of approximately \$600,000. Borrowing to finance this capital project is authorized. Approval of this capital project includes authorization to expend funds, not to exceed the total amount of the appropriation, for all associated and incidental and customary costs and charges associated with, and reasonably required for, financing, planning, design, construction, and completion of the project. All costs incurred for this capital project shall be repaid from revenues generated by operation of the Region II (St. Michaels) Wastewater Treatment Plant. \$600,000 in funds from long-term borrowing will fund the project. This represents an increase of \$50,000 over prior authorizations. The increase is funded by additional long-term borrowing of \$200,000 and a decrease in federal and State grants of \$150,000.

SECTION 3: This ordinance will take effect sixty (60) calendar days from the date of enactment.

SECTION 1: A Master Plan for the development of and potential transfer to Talbot County of approximately twenty (20) acres of the Bill Burton State Park is hereby authorized as a capital project. The scope of work includes, but is not limited to, the preparation of a Master Plan that would include the design and construction of a park to include park access and walking trails while preserving the natural characteristics of the property, for the potential transfer of this property to Talbot County Maryland. The Master Plan must incorporate staffing requirements for the operation and maintenance of the park and provide an annual projected budget for the same. Approval of this capital project includes authorization to expend funds, not to exceed the total amount of the appropriation, for all incidental and customary costs and charges associated with and reasonably necessary for completion of the project.

SECTION 2: The Talbot County Council is hereby authorized to expend up to \$50,000 for this project. This project will be funded by \$50,000 of County funds from the Capital Projects Fund.


