Easton, Maryland MINUTES December 21, 2012

Present – President Dirck K. Bartlett, Thomas G. Duncan, Laura E. Price, County Manager John C. Craig, and County Attorney Michael Pullen. Vice President Corey W. Pack and Council Member R. Andrew Hollis were absent.

- I. <u>Call to Order</u> The meeting was called to order at 12:00 p.m. by Mr. Bartlett and unanimous consent by Council.
- II. Council Consideration of Proposal to Enter Into a Long-Term Lease of 9415 Jet Lane, Easton Airport,

  Easton, Maryland Mr. Pullen provided an overview of the terms of the proposed lease between Talbot
  County, Maryland and Easton Jet Service for a hangar located at 9415 Jet Lane at Easton Airport, noting a
  correction to be made to the term of the lease. Mr. Pullen noted that it is staff's recommendation for
