MINUTES

February 25, 2020

Present – President Corey W. Pack, Frank Divilio, Pete Lesher, Laura Price, County Manager R. Andrew Hollis, County Attorney Anthony Kupersmith, and Assistant County Attorney, Mary O'Donnell. Vice President Chuck F. Callahan was absent.

I. <u>Agenda</u> – The Agenda of Tuesday, February 25, 2020 was brought forward for approval. Mr. Divilio made a motion to amend the Agenda to include the following bills for Council discussion: HB 4, HB 1257, and HB 636; Ms. Price seconded the motion. Ms. Price made a motion to amend the Agenda to include SB 1000/HB 1300 (Kirwan legislation); as there was no second the motion failed. Upon motion by Mr. Lesher, seconded by Mr. Divilio, Council approved of the Agenda of Tuesday, February 25, 2020, as amended, by voting 4 – 0 as follows:

- II. <u>Minutes</u> Mr. requested and received Council's unanimous consent for approval of the Minutes of Tuesday, January 28, 2020.
- III. <u>Disbursements</u> Mr. Pack requested and received Council's unanimous consent for approval of the Disbursements of Tuesday, February 18, 2020, and Tuesday, February 25, 2020.
- IV. <u>Certificate of Recognition: 100th Anniversary of Blake Blackston American Legion Post 77</u> Prior to presentation of the proclamation, Mr. Pack expressed his appreciation to the members of Post 77 for service to their nation as well as to the citizens of the community. Members of American Legion Post 77 briefed the Council on the upcoming event scheduled to commemorate their 100th anniversary, outlined the support provided to veterans, their families, youth, and the community at large and their plans for expanding the facility at its current location in order to serve more citizens. The Clerk then read the Certificate of Recognition into the record which spoke of the 100th anniversary of the founding of the American Legion and the history of the naming of Post 77 in honor of World War I missing in action soldiers, Nelson Blake of Unionville and John Blackston of Trappe. Council members expressed their appreciation to members of the organization for their valuable contributions to the community. Upon motion by Mr. Divilio, seconded by Mr. Lesher, the Council approved the Certificate of Recognition by voting 4 0 as follows:

Mr. Pack presented the Certificate of Recognition to the representatives of Blake Blackston American Legion Post No. 77 in attendance.

V. Update by Maryland Environmental Service – Steve Tomczewski, Managing Director, Environmental Operations, Maryland Environmental Service - Mr. Tomczewski utilized a PowerPoint presentation to outline services provided by Maryland Environmental Services (MES) and to provide statistical information on tonnage of solid waste and yard waste received and homeowner drop-off customers utilizing the Mid-Shore I transfer station and the Mid-Shore II Regional Solid Waste Facility for the timeframe July 2019 through December 2019. He stated that 65,871,000 standard cubic feet of landfill gas was produced, generating \$24,585 in revenue toward the closure costs of Mid-Shore I. Mr. Tomczewski provided an update on the status of the newest cell, Cell 3, at Mid-Shore II, which began receiving soft trash in January 2020. He provided information on the status of the wetland mitigation at Ackerman Farm, a 16.8 acre site adjacent to Mid-Shore II, an overview of the Mid-Shore Recycling Program, including tonnage received of various materials, and the clean-up and inspection of used oil sites in Talbot County. Council discussion ensued with Mr. Tomczewski as various items were brought forward. Maryland Environmental Service will continue to update the Council on a regular or as needed basis.

VI. Introduction of Administrative Resolution:

A RESOLUTION OF TALBOT COUNTY, MARYLAND (THE "COUNTY"), AUTHORIZING THE ISSUANCE AND SALE OF GENERAL OBLIGATION BONDS IN A PRINCIPAL AMOUNT NOT EXCEEDING TWO HUNDRED TWENTY TWO THOUSAND DOLLARS (\$222,000) PURSUANT TO THE AUTHORITY OF BILL NO. 1440 ENACTED BY THE COUNTY COUNCIL OF TALBOT COUNTY ON JANUARY 14, 2020 (THE "PUBLIC LOCAL LAW"), SECTION 10-203 OF THE LOCAL GOVERNMENT ARTICLE OF THE ANNOTATED CODE OF MARYLAND (2013 REPLACEMENT VOLUME, AS AMENDED) (THE "ENABLING ACT") AND SECTION 623 OF THE CHARTER OF TALBOT COUNTY, MARYLAND (THE "CHARTER"), THE BONDS, TO BE DESIGNATED "TALBOT COUNTY ST. MICHAELS WASTEWATER SYSTEM CONSOLIDATED PUBLIC IMPROVEMENT BONDS", THE NET PROCEEDS OF THE SALE THEREOF TO BE USED AND APPLIED FOR THE PUBLIC PURPOSE OF FINANCING OR REFINANCING REHABILITATION IMPROVEMENTS TO CERTAIN WASTEWATER FACILITIES LOCATED WITHIN THE COUNTY AS MORE PARTICULARLY DESCRIBED HEREIN, TOGETHER WITH FINANCING OR REFINANCING OF THE ACQUISITION OF ALL NECESSARY PROPERTY RIGHTS AND EQUIPMENT, AND RELATED ARCHITECTURAL, FINANCIAL, LEGAL, PLANNING AND ENGINEERING EXPENSES; PRESCRIBING THE FORM AND TENOR OF THE BONDS AND THE TERMS AND CONDITIONS FOR THE ISSUANCE AND SALE THEREOF AT PRIVATE SALE TO THE UNITED STATES OF AMERICA, ACTING THROUGH RURAL UTILITIES SERVICE, UNITED STATES DEPARTMENT OF AGRICULTURE ("USDA"); AUTHORIZING THE CONSOLIDATION OF SEPARATE SERIES OF BONDS INTO ONE OR MORE BONDS; PROVIDING FOR THE PROMPT PAYMENT OF THE MATURING PRINCIPAL OF AND INTEREST ON THE BONDS; COVENANTING TO LEVY AND COLLECT ALL TAXES NECESSARY TO PROVIDE FOR THE PAYMENT OF THE PRINCIPAL OF AND INTEREST ON SUCH BONDS, SUBJECT TO THE LIMITATION SET FORTH IN SECTION 614 OF THE COUNTY CHARTER; AND GENERALLY RELATING TO THE ISSUANCE, SALE AND DELIVERY OF THE BONDS, was brought forward for introduction. Prior to introduction, Angela Lane, Finance Director, stated that the purpose of the administrative resolution is to finalize the County's borrowing with USDA Rural Development for the St. Michaels Wastewater Treatment Plant. Ms. Lane stated that the Council had previously approved a USDA resolution and had adopted enabling legislation to borrow the funds; the administrative resolution sets forth some of the general terms of the bonds related to the borrowing. The administrative resolution was introduced by Mr. Divilio, Mr. Lesher, Mr. Pack, and Ms. Price. Upon motion by Mr. Divilio, seconded by Mr. Lesher, the Council approved the administrative resolution by voting 4 - 0 as follows:

The Administrative Resolution is effective immediately.

VII. <u>Public Hearings:</u>

Bill No. 1442, A BILL TO AMEND CHAPTER 11 OF THE TALBOT COUNTY CODE (ALCOHOLIC BEVERAGES) TO ALLOW THE BOARD OF LIQUOR LICENSE COMMISSIONERS TO ISSUE A LICENSE FOR ON-PREMISES CONSUMPTION OF MIXED DRINKS TO CLASS ONE DISTILLERIES, *and amendments*, were read into the record by the Clerk and brought forward for public hearing. Mr. Callahan joined the meeting by telephone at 6:44 p.m. The public was afforded an opportunity to comment on the legislation and the proposed amendments. Council discussion ensued. Amendment No. 1, known as the purple amendment, was brought forward for vote. Mr. Pack passed the gavel to Mr. Divilio since Vice President Chuck Callahan was not physically in attendance and upon motion by Ms. Price, seconded by Mr. Pack, the Council did not approve Amendment No. 1 by voting 1 – 4 as follows:

Mr. Divilio returned the gavel to Mr. Pack.

Amendment No. 2, known as the salmon amendment, was brought forward for vote. Mr. Divilio, one of the sponsors of the legislation, stated that he wished to withdraw the amendment from consideration; Mr. Callahan, also a sponsor of the amendment, seconded that he too wished to withdraw the amendment from consideration. Ms. Price stated that she wanted to have an up or down vote on the amendment. Upon motion by Ms. Price, seconded by Mr. Callahan, the Council did not approve Amendment No. 2 by voting 2-3 as follows:

Mr. Divilio made a motion that a full reading of the legislation be waived. Mr. Pack requested, and Ms. Price concurred with the request, that a full reading of the legislation be read into the record. The

legislation was then read into the record by the Clerk. The Council approved Bill No. 1442 by voting 4 - 1 as follows:

- VIII. <u>Council Discussion of the following 2020 Maryland General Assembly Legislation:</u> The following bills were read into the record by the Clerk and brought forward for Council discussion and members of the public were afforded an opportunity to comment on each of the bills. At the conclusion of the comments on each bill, Council voted as follows:
 - A. HB388 CRIMINAL PROCEDURE CIVIL IMMIGRATION ENFORCEMENT RESTRICTIONS – Mr. Lesher requested more time to gather more information on the proposed legislation and requested that discussion on the legislation be continued to the meeting of Tuesday, March 10, 2020; there was no objection.
 - B. HB403/SB903 IMMIGRATION ENFORCEMENT PUBLIC SCHOOLS, HOSPITALS, AND COURTHOUSES POLICIES Upon motion by Ms. Price, seconded by Mr. Divilio, the Council voted to take "no position" on the legislation by voting 2 2 as follows:

Ms. Price then asked for a Point of Order as to whether a vote on the first motion needed to be taken prior to any further motions being made; County Attorney Anthony Kupersmith stated that a vote

did need to be taken prior to any further motions, unless the motion is to modify the initial motion. Upon motion by Ms. Price, seconded by Mr. Lesher, the Council approved taking "no position" by voting 4-0 as follows:
