- IV. Presentation of Proclamation: May as Drug Court Month in Talbot County The Clerk read a proclamation into the record in recognition of May as Drug Court Month in Talbot County. The Juvenile, Family and Adult Drug Courts combine judicial accountability and evidenced-based treatment as an intervention for substance abuse. Since becoming operational in Talbot County in 1998, the Drug Court has been deemed highly successful in reducing the rate of recidivism. Mr. Bartlett introduced various individuals and community agencies that comprise the team approach to substance abuse intervention in Talbot County. The proclamation emphasized the challenges, dangers and rewards correctional officers encounter in the performance of their duties as well as the officers' contributions toward promotion of positive behavior, attitudes and skills that will improve the offenders' chances of becoming productive members of society once released from custody. ### D. Bid No. 11-07, TALBOT COUNTY PUBLIC SAFETY CENTER ROOF REPAIR -

## VII. <u>Public Hearing</u>:

Prior to the public hearing on Bill No. 1203, County Manager John Craig stated that the proposed legislation establishes the General Fund Budget for Fiscal Year 2012 in the amount of \$65,945,000, a decrease of 8.81% from the FY 2011 Budget. He stated that the Talbot County Budget has been reduced by \$20.3 million, or 23.53%, in the last five years. The proposed FY 2012 Budget utilizes \$2,350,000 of Reserve Funds; eliminates 16 full-time positions, provides for no salary increases, provides that employees of the County pay 15% toward their healthcare costs, provides for no transfers to the Capital Projects Fund, reduces funding for each department, and provides for a reduction in public school funding for the first time in more than 20 years. Mr. Craig provided U.S. Census Bureau and City-Data.com statistical information on the average household in Talbot County as it relates to 2009 income and home value guidelines, correlating the statistical information to changes in income taxes and property taxes, should the proposed legislation be enacted. He outlined each category of FY 2011 Revenues and anticipated FY 2012 Revenues, and highlighted the percentage of change. Mr. Craig reiterated the County's priority to reduce expenses and to maintaining a Reserve Fund. He stated that County citizens should anticipate reduced or delayed services from some County departments as a result of employee layoffs. Mr. Craig presented the Board of Education's funding request for FY 2012 in the sum of \$37,064,877, stating that the County's proposed funding to the Board of Education in the sum of \$32,403.006 is a reduction from both the amount requested by the Board, and is \$1.8 million less than that required by Maintenance of Effort. He continued that the proposed funding does include funding of the Board of Education's Capital requests. He stated that the proposed reduced funding from the County is neither a reflection on the performance of teachers or schools, nor is it meant to be punitive. He stated that in the County's opinion, it is a necessary reality, given the economic realities of the County, State and nation, adding that the reduction was proposed after careful consideration and anguish on the part of the County, and is, in the County's opinion, legal. Mr. Craig briefly explained the Maintenance of Effort requirements, advising that the County had requested a waiver from the requirement for FY 2012 on April 1, 2011; further advising that the request for a waiver had been withdrawn on May 2, 2011. Mr. Craig concluded his comments by stating that the FY 2012 proposed Budget and the 2012 Budget are on the County's website.

A public hearing was held on Bill No. 1203, AN ACT TO ESTABLISH THE 2011-2012 ANNUAL BUDGET AND APPROPRIATION ORDINANCE, and the public was provided an opportunity to comment on the legislation. Written comments on Bill No. 1203 will be accepted by the Office of the Talbot County Manager until Friday, May 6, 2011 at 12:00 Noon.

VIII. Upon motion by Mr. Pack, seconded by Mr. Hollis, the Council voted to recess the meeting, to reconvene in Executive Session for discussion of legal, personnel and real estate matters, to reconvene at the Easton High School Cafeteria at 7:00 p.m. for a continuation of the public hearing on Bill No. 1203, and to reconvene in Executive Session on Tuesday, on Tuesday, May 10, 2011 at 12:30 p.m. for discussion of legal, personnel, and real estate matters, and for the regularly scheduled meeting at 1:30 p.m. by voting 5 – 0 as follows:

IX. On Tuesday, May 3, 2011 an Executive Session of the Talbot County Council convened at 12:33 p.m. in the County Council Conference Room and the Bradley Meeting Room. Upon motion by Ms. Price, seconded by Mr. Duncan, the Council met in Executive Session by voting 4 to 0 as follows:

In accordance with State Article §10-508(a) (1)(i)(ii)(3)(4)(7)(8) the purpose of the Executive Session was for discussion of a personnel matters to discuss appointments to various County boards and committees and to discuss personnel matters involving the budget; for legal matters for legal advice on pending litigation involving the County; for a legal/real estate matter involving legal advice concerning possible relocation of Memorial Hospital at Easton to County owned property and timetable for same; for a real estate matter to discuss possible acquisition of property for a public purpose. The meeting recessed at 1:30 p.m., and reconvened at 4:10 p.m. The Executive Session ended at 5:40 p.m.

The transcript of the May 3, 2011 County Council meeting is available for review in the Office of the County Manager during regular office hours.

X. A continuation of the public hearing on Bill No. 1203 was held at 7:00 p.m. at the Easton High School Cafeteria, 723 Mecklenburg Avenue, Easton. Prior to the continuation of the public hearing, County Manager John Craig outlined the provisions of the County's FY 2012 Budget Ordinance as he had previously done at the 2:00 p.m. public hearing. Following Mr. Craig's presentation, Council members made the following comments:

Mr. Hollis - Mr. Hollis stated that all comments by the public will be given consideration.

Mr. Pack – Mr. Pack stated that he looked forward to hearing comments from the public.

Ms. Price - Ms. Price stated that the Council members are County citizens and that neither she nor her colleagues enjoy making budget cuts that affect their friends. She stated that the Council was elected to do a job and, in her opinion, they have to do it. She stated that several years ago, most people, including the Council, thought the County's budget problems would be short-lived; now they understand that the problem is not going away and the County cannot continue to deplete its remaining savings. She continued, that just like a family, the County must start living within its means; times have changed which require that no area of government can remain untouched. She reiterated that the Council had requested that all departments pull together to meet the budget challenges. She stated that she is the

mother of two children in the public school system, and she also wants the best education system possible for Talbot County – that the County can afford. She stated that, in her opinion, the schools must also share the burden and believes that the members of the Board of Education who were elected by the citizens can make the right decisions, adding that the County must be fair to its school children, but must also be fair to the other 38,000 citizens in the County by providing emergency, health and public safety services which are needed. She stated her belief that the budget as presented is a fair, honest, balanced approach to finding savings which will least affect County citizens, acknowledging that some departments will be hurt, but that everyone needs to make sacrifices to make ends meet. Ms. Price concluded her comments by stating that, in her opinion, the Council has done its best to try to protect the interests of all County citizens in these very trying times.

Mr. Duncan -

Mr. Duncan quoted Abraham Lincoln, "You cannot escape the responsibility of tomorrow by evading it today." He stated that he had been a member of the Council for a long time and had seen many ups and downs; however, in his opinion, this has been the toughest year thus far in working out how to provide for public services, including education, at a time when revenues continue to decline. He stated that every member of the Council would like to be able to provide the schools with more money, and to provide pay raises for the dedicated teachers and support staff. He stated that there is really only one line in the budget which everyone needs to understand, Total General Fund Revenues, which have dropped from approximately \$81.5 million in FY 2008 to the projected \$65.9 million for FY 2012, a decrease of more than 20 percent, adding that that is the reason the County has had to make such hard budget choices. He reiterated that by law the County cannot operate at a deficit, and encouraged those who wanted more money for schools or other programs to come forward and identify a source for the additional funding.

The public hearing was then continued on Bill No. 1203, AN ACT TO ESTABLISH THE 2011-2012 ANNUAL BUDGET AND APPROPRIATION ORDINANCE, and the public was afforded an opportunity to comment on the legislation. Written comments will be accepted by the Office of the Talbot County Manager until Friday, May 6, 2011 at 12:00 Noon. Bill No. 1203 is eligible for vote on Tuesday, May 24, 2011.
