Budget Overview

- The County Council received funding requests for Operating and Capital Outlay of \$98,962,440, which is \$6.9 million dollars more than the current FY 2019 budget.
- The FY 2020 Budget reflects a slight decrease from the current General Fund Budget. This Budget is funded in part with revenues of almost \$4.0 million from Prior Year Fund Balance.
- Great effort was taken in the development of this budget which maintains current services for our citizens while continuing to maintain two of the lowest tax rates (Property Tax and Income Tax) in the state.



PROPERTY TAX CAP FY 2020 PROPOSED BUDGET

In order to fund expenses for the public school system, the Talbot County Council has proposed to override the voter imposed Property Tax Revenue Cap. This is authorized by State law in order to fund Education expenses only. This budget proposes to override the tax cap by \$1,345,500, which correlates to an increase of 1.8¢ in the Real Property Tax rate.

Budget Highlights

- Talbot County Public Schools (TCPS) operating appropriation is \$936,330 above the required level of Maintenance of Effort (MOE), an increase of \$1,844,227 from FY 2019. The County is funding an additional \$409,170 for programs not included in Maintenance of Effort, as well as an additional \$3.7 million in debt service. Debt Service has increased by over \$1 million from FY 2019 to pay for one half of the annual debt service on the new Easton Elementary School (County share of \$30 million).
- The County appropriation increase to TCPS of \$1,844,227 is a 4.63% increase from FY 2019 appropriation for the Public Schools. TCPS will also receive an additional \$665,518 in State funding that was added by the State legislature.
- The FY 2020 Capital Projects Budget includes the following projects for the Talbot County Public Schools:
 - \$11.0 million for a new Easton Elementary School, bringing the total County contribution for this project to \$30 million.

Budget Highlights

- No change in number of full time positions
- Salary scale adjustments for Sheriff Deputies and Correctional Officers to address recruitment and retention issues
- 1 part time Housing Coordinator position added
- Step increase and 1% COLA for full time County employees



GENERAL FUND REVENUES FY 2020 PROPOSED BUDGET







- Additional positions for the Sheriff's Office
- 25 Year retirement for Law Enforcement personnel
- Additional position for the State's Attorney Office
- EMS Station for Northern part of County to address response time concerns
- EMS Station relocation to address response time concerns in the Bay Hundred area
- New facility for the Sheriff's Office
- County storage currently at the Talbot County Business Center
- New facility for the Health Department
- Roads Department equipment requests (requested \$2.4 million this budget includes \$435,000)
- Additional full time County positions
- Full year's debt service for the Easton Elementary School
- Full funding of the TCPS Budget request
- Impact of minimum wage increasing to \$15.00/hour over the next few years
- Replacement of 40 year-old irrigation system at Hog Neck Golf Course

Budget Recap

Public Safety is again the highest priority in this Budget

- Additional Public Safety enhancements to retain and recruit staff
- Increase in funding for public schools of \$1.8 million and additional funding for expenses not included in MOE of \$409,170
- First semi annual debt service payment of \$1.0 million for the new Easton Elementary School
- No increase in full time County positions
- The General Fund balance is available, but shrinking. Long term sustainability must be preserved
